A STRATEGIC MAKEOVER: REDESIGNING JLNV'S 2013-2016 GOALS

Debunking the idea that members take the summer off, the JLNV Board of Directors met in June to vote on the adoption of the redesigned 2013-2016 Strategic Plan and the 2013-2014 Annual Plan. We are proud of the Strategic Plan's engaging new look.

The Strategic Plan underwent a full remodel over the course of the last League year. The Planning Council's Strategic Advisory Planning Committee logged countless hours seeking guidance from League leaders and working alongside other committees to overhaul JLNV's Strategic Plan into a streamlined, attractive, and user-friendly document that would both reflect and guide the direction the League is taking in the coming months and years.

The revised Strategic Plan was designed to help members better navigate their path in the League whether as an Active member, leader, or supportive Sustainer. It also speaks clearly to the priorities of the League within our organization and within our community, recognizing our continued work in identifying a defined focus area to enhance community impact and reflect the changes to our membership engagement initiatives. Additionally, the 2013-2016 Strategic Plan displays JLNV's renewed emphasis on capturing and applying metrics in building a financially strong, diversified organization. Underlying each of JLNV's strategic goals is the central objective to incorporate a stronger focus on brand awareness, which requires effective internal and external communications.

As members, we often find ourselves busily working on all the programs and projects that keep our League running and forget to step back and take a look at all the great work we are doing in the context of the larger picture. However, our volunteer work directly and collectively impacts a greater vision in building better communities throughout Northern Virginia.

CHILDREN'S SCIENCE CENTER -FROM CONCEPT TO REALITY



The Junior League of Northern Virginia's (JLNV) President's theme this year is "Cultivate. Collaborate. Change." This sentiment is precisely what the JLNV has done with the Children's Science Center over the years. Our relationship began as a collaboration to develop a children's museum focused on science, technology,

engineering and math (STEM) in Northern Virginia. The initial memorandum of understanding (MOU) provided capital funding and JLNV volunteer hours to the Children's Science Center as they began their journey toward a full-scale museum.

Over the years, the JLNV and the Children's Science Center's relationship has matured and the museum's programming has grown. In the beginning, the JLNV had a Children's Science Center Partnership Committee (CSCPC) that organized and led the Center's educational programming—Museum Without Walls (MWOW). In addition, the CSCPC chair also held a seat on the museum's Board of Directors. This year, the relationship continued to develop: the dissolution of the CSCPC resulted in the assignment of six JLNV volunteers on an In-Community Placement. One thing that has not changed is the presence of a JLNV member on the Children's Science

Center Board who is responsible for continually cultivating the relationship between the two organizations.





In addition to the changing relationship, MWOW programming has also evolved over the years. What began as small, craftbased programming at local fairs and festivals serving a few hundred visitors has grown into multi-faceted, handson education that takes place in multiple venues and serves thousands of visitors each year. Mobile Labs are one component of this growth. Debuting in January 2012, Mobile Labs Family Science Nights quickly became a hot commodity. During the 2012-2013 school year, the available Mobile Labs for the year were booked before the first month of school was completed. This year, Mobile Labs has continued to grow and has been reengineered through collaboration between JLNV and Children's Science Center members. This new programming will be seen at 40 schools this year, and is expected to serve twice as many visitors as last year's programming.

What is next in the relationship between these two organizations? Only time will tell. The current MOU expires in 2015, but it is doubtful this will be the end of the relationship. At a minimum, JLNV members and the Northern Virginia community will be able to enjoy visiting the Children's Science Center when the physical building opens its doors.



REACH OUT AND READ-A PARTNERSHIP WITH HEALTHWORKS FOR NORTHERN VIRGINIA

The Junior League of Northern Virginia (JLNV) has partnered with HealthWorks for Northern Virginia to implement the Reach Out and Read Program. HealthWorks for Northern Virginia is a nonprofit that provides medical, dental and behavioral health care to anyone in need regardless of age or ability to pay, whether or not they have insurance. HealthWorks focuses on serving lowincome families that face significant socio-economic, language and cultural barriers to obtaining health care. Reach Out and Read is a national program that builds on the unique relationship between parents and medical providers to promote early literacy and school readiness in pediatric exam rooms nationwide by giving new, developmentally-appropriate and carefully selected books to children and advice to parents about the importance of reading aloud. The program begins to develop critical early reading skills in children at the 6-month checkup and continues through age 5, with a special emphasis on children growing up in low-income communities.

JLNV's participation in the Reach Out and Read program with HealthWorks of Northern Virginia is in full swing. We endowed HealthWorks with a \$5000 grant to start a program that provides books for patients between the ages of 6 months and 5 years when they come to the clinic for a well visit. These books are divided among three offices: Leesburg, Sterling and Herndon. They are shelved and catalogued by age, language and title



for easy access for the doctors. The books are approximately 70 percent bilingual (Spanish/English) and 30 percent in English to best meet the demographic needs of the community served. Books will be continuously replenished as they are used and will be important "icebreakers" for the patients and their families. In addition, clinical staff will use the books as diagnostic tools when working with patients.

The League is also hoping to collect some "gently used" children's books from JLNV members and the community to put in the waiting rooms for the siblings who accompany patients. We hope to 'reach out' through community service hours by spending some time reading to and with children in the waiting rooms.

MISSION ACCOMPLISHED -500 BACKPACKS FOR KIDS IN NEED

Through the JamPacks program, the Junior League of Northern Virginia (JLNV) spent summer 2013 gearing up to prepare local children for back to school. JamPacks, now in its 20th year, contain backpacks, pencils, binders, pens, erasers, and other essential school supplies. League members "jam pack" every backpack for the region's underserved school age children to have the required supplies to begin the school year.

The JamPacks program kicked-off on June 1 at JL101 with the donation of 20 backpacks, and members in attendance stuffed 100 backpacks with school supplies. The 2013 goal for JamPacks

was to provide 500 backpacks (150 more than any other year) to children around the region.

The 2013 JamPacks "stuffing party" was held on July 14 with 24 volunteers and the remaining 400 backpacks are now ready to be distributed. The League is proud to be able to provide such an important item for local Northern Virginia children and to have reached our goal of 500 backpacks on the 20th anniversary of this program.



COMMUNITY PARTNERSHIP PROGRAM APPLICATION ANNOUNCEMENT

The Junior League of Northern Virginia (JLNV) Community Partnership Committee is pleased to announce the opening of our 2014-2015 Community Partnership Program applications. Every year, the JLNV awards grants to local community organizations that share our focus of preparing children for success.

Through the Community Partnership Program, the JLNV awards grants of funds and / or volunteer hours to support Northern Virginia community programs in Alexandria, Arlington, Fairfax County, and Loudoun County. The JLNV's community partnership support varies in size each year, contingent upon the financial and volunteer resources available. For the 2014-2015 year, the grant awards will range from \$1,500 - \$3,000. In addition, community partners may also be provided with volunteers (up to 100 hours) to support selected projects. The community partnership term for the coming year is from June 2014 – May 2015. While the League may support a community partnership for multiple years, organizations must reapply every year.

The number of grants awarded and their dollar value is based on the success of our fundraising efforts. Last year the Grants Committee received 12 applications from 10 non-profit organizations and awarded seven grants totaling \$17,500 and 175 volunteer hours. Past recipients include the Children's Science Center, Girls on the Run, HealthWorks of Northern Virginia and Loudoun County 4-H.

In 2014-2015, the JLNV would like to support innovative projects and programs that will measurably improve the lives of children in our community. In particular, the JLNV is focused on supporting programs that ensure access to preventive care and empower children to make healthy food and lifestyle choices. We hope that this, in turn, will help reverse the growth of childhood obesity and its associated health issues. Moreover, the JLNV would like to partner with like-minded organizations. We encourage JLNV members and individuals in the community to take an active role in identifying our future partners.

2014-2015 COMMUNITY PARTNERSHIP TIMELINE

October 4, 2013: Applications from community organizations for 2014-2015 League year due.

October – January: JLNV representatives review applications and meet with agency/community organizations as applicable.

January 2014: Community Partnership Committee presents recommendations to JLNV Board.

February 2014: Grant awards announced to applicants.

May 2014: Grants awarded at the JLNV's Celebration of Service event.

June 2014: Volunteer hours and funds available for 2014-2015 League year.

PROVISIONAL CLASS PROGRAM RESTRUCTURE

Northern Virginia is home to many recent transplants. Often, women new to our area look for ways to become involved in their new community. The Junior League of Northern Virginia (JLNV) strives to connect with as many of these women as possible. In doing so, the JLNV has introduced a new Provisional Program for the 2013 – 2014 League year. New JLNV members, or Provisionals, now have the opportunity to join the JLNV at three different entry points – at the end of May, September, or January. For the past several years, Provisionals were required to join the JLNV in either the summer class or the fall class and were required to complete a year-long new member program. Now, each six- or eight- week Provisional Program will consist of two training events planned by the Leadership Development Committee, a placement on an Active committee, and a placement in a Regional Small Group with other Provisional, Active and Transfer Members.

Our summer 2013 Provisional Class includes 52 women committed to voluntarism and an interest in affecting change on the Northern Virginia community.

INTRODUCING THE 2013-2014 ISSUE BASED COMMUNITY IMPACT AD HOC COMMITTEE

During the past year, the Issue Based Community Impact (IBCI) Ad Hoc Committee has researched community needs and member interests in an effort to help move our League toward the IBCI model recommended by the Association of Junior Leagues International, Inc. (AJLI). The IBCI model gauges community need and evaluates how each League can have the greatest impact in its community by creating projects and programs that specifically target a focus area. This approach allows the League to create maximum impact within the community by focusing efforts toward a specific goal. It also provides League members a concrete and consistent message to deliver to the community, potential members, our partners and sponsors.

In April 2013, the Junior League of Northern Virginia (JLNV) voted to adopt the following areas corresponding to the IBCI model: a topic area of Preparing Children for Success, an issue area of Health and Wellness, and a focus area of Addressing Childhood Obesity.

Since introducing the IBCI Ad Hoc Committee to our League last fall, the committee's membership and makeup has changed to better provide the expertise and commitment required of such a specialized research effort. A SPECIAL SUMMER TREAT: BEST EVER BLUEBERRY COBBLER

Best Ever Blueberry Cobbler (page 258) Serves 6

3 cups fresh blueberries 3 Tablespoons sugar 1/3 cup orange juice ½ cup unsalted butter, softened ½ cup sugar 1 large egg ½ teaspoon vanilla extract 2/3 cup all-purpose flour ¼ teaspoon baking powder Pinch of salt



Preheat over to 375 degrees.

Toss together first 3 ingredients in an 8 x 8 x 2 baking dish.

Beat butter and ½ cup of sugar at medium speed with an electric mixer until light and fluffy. Add egg and vanilla, beating until smooth. Gradually add flour, baking powder, and salt, beating at low speed. Drop batter in small clumps over blueberry mixture, covering as much surface as possible.

Bake at 375 degrees for 35 to 40 minutes or until crust is golden brown and filling is bubbly. Let cool briefly on a wire rack.

Serve warm with whipped cream or vanilla ice cream.
