As the League year comes to a close, it's time to look back on the accomplishments of the last 12 months. We established a new community program, welcomed more than 100 women into our organization, and held two successful fundraisers—all of which you can read about in the following pages.

One of the major tasks Leagues across the United States, Canada, Mexico and England have helped to accomplish this year is the creation of a new reaching out statement. At the 2015 Annual Conference in Los Angeles, the Association of Junior Leagues International (AJLI) unveiled the final results of a long process that began at the 2013 Annual Conference following an advisory resolution to review AJLI's previous 40-year-old statement.

Through the work of a dedicated task force, as well as work groups and discussions at AJLI conferences through the last two years, the original statement — "Junior Leagues reach out to women of all races, religions and national origins who demonstrate an interest in and commitment to voluntarism"— was revised to following:

Our Commitment to Diversity and Inclusion

The Junior League welcomes all women who value our Mission. We are committed to inclusive environments of diverse individuals, organizations and communities.

This will now appear on AJLI's website to encourage participation in Junior Leagues by all women who share our dedication to AJLI's mission. 2015-2016 JLNV BOARD OF DIRECTORS EMPOWERED TO CONNECT MEMBERS AND IMPACT COMMUNITY CHANGE

Jennifer Williston, Nominating & Placements Chair 2014-2015

In June 2015, the 2015-2016 JLNV Board of Directors will take the helm with more than 95 combined years of Junior League experience. The average board member has at least seven years Junior League experience, and the group combines experience from both in the Junior League of Northern Virginia and other Junior Leagues across the country such as the Junior League of Annapolis, Maryland; Long Beach, California; Philadelphia; and Wilmington, Delaware. Many board members have extensive volunteer experience serving on local community boards, and some are returning for their second or third stint of service on the JLNV Board.

President Beatrice (Bea) Duque Long leads this group of impressive women after serving as the President-Elect in 2014-15 and working closely with the Community Advisory Board. Originally a transfer from the Junior League of Long Beach and a native of Colombia, Bea has served the Junior League of Northern Virginia since 2008. Her past JLNV roles include Planning Council director, chair of the Kids in the Kitchen and Community Partnership committees, a member of the Issue Based Community Impact Committee, and various committee positions including Finance Council and the Nominating and Placements Committee. Professionally, Bea works in the field of health policy and advocacy for the National Epilepsy Foundation.

President-Elect Lori Ann Terjesen is a former Community Council director and has been instrumental in JLNV's work with the Children's Science Center (CSC). Lori Ann currently serves as CSC's director of education and has leveraged her extensive museum background to design and implement numerous successful hands-on activities and mobile exhibits. She earned a doctorate in art history and museum studies from Case Western Reserve University and received her master of arts

degree in museum studies from Seton Hall University, as well as a post-baccalaureate certificate in nonprofit organization management.

Treasurer Gretchen Ehle has served on the JLNV Board twice before serving as Treasurer-Elect — once as parliamentarian and once as the Nominating and Placements Committee chair. Professionally, Gretchen serves as the Vice President of Global Connect for the Meridian International Center. Gretchen's work on the Finance Council is supported by Treasurer-Elect Jhaymee "JW" Heinlein.— a JLNV member since 2007 who is a manager with Deloitte Consulting, focused on business transformation for healthcare providers. In addition to her work with JLNV, in her spare time, JW is a member of the Psychiatric Rehabilitation Services (PRS, Inc.) board of directors and is a former board member of CrisisLink.

Rounding out the council director positions are Martha Hess, Communications Council director; Celia Anderson, Community Council director; Kelly Cruz, Fund Development Council director; Jennifer Bell, Membership Council director; and Kimberly Beach, Planning Council director. Kelly and Kimberly are returning to the Board of Directors after serving as the secretary and parliamentarian, respectively, on the 2014-15 Board. Martha and Jennifer are both first-time board members who have extensive experience in their designated councils and joined the JLNV as transfers from other Leagues. Another first-time board member, Celia has stepped up to lead and further develop JLNV's community programs after spending the 2014-15 year creating innovative programming and activities as the chair of the Kids in the Kitchen Committee.

Rounding out the Board of Directors are Secretary Stephany Smith, who most recently served two terms as the Fund Development Council director; parliamentarian Kelly Atkinson, who tirelessly chaired The Enchanted Forest fundraiser in back-to-back years; Nominating and Placements Committee chair Elizabeth Ross, and Sustainer Representative Alyssa Redding. A member of JLNV for eight years, Elizabeth is already hard at work on the League's Placements for 2015-16, and Alyssa is joining the Board of Directors after serving

a three-year appointment as the JLNV representative to the Fairfax County Community Action Advisory Board.

Charged to empower, connect and change, the 2015-16 Board of Directors are poised to advance a legacy of service, leadership and community impact.

WEIGHT OF THE STATE

Alyia Gaskins, Community Council Director 2014-2015

In April, six members traveled to Richmond, Va., to represent the Junior League of Northern Virginia (JLNV) at the fourth Weight of the State conference on childhood obesity. This conference, which is sponsored by the Virginia Foundation for Healthy Youth and Prevention Connections, brings national, state and local experts together to highlight best practices for reducing childhood obesity and promoting healthy, active lifestyles.

Attending the conference provided an opportunity to raise the visibility of the JLNV and network with other organizations both in Northern Virginia and across the state. Additionally, interactive workshops and sessions offered a forum for members to increase their understanding of the prevalence of childhood obesity, the consequences of poor health, and innovative solutions. This knowledge will be critical as the League continues to develop new programs and partnerships in this focus area.

The conference also offered opportunities for League members to practice their leadership skills, which is core to our mission of developing the potential of women and training our volunteers. The six JLNV members moderated panel discussions on creating healthy eating and active living communities, the connections between childhood hunger and childhood obesity, and the importance of community collaborations and partnerships.

One of the highlights of the conference was meeting the First Lady of Virginia, Dorothy McAuliffe, and hearing her passion for ensuring that all children in the Commonwealth have access to healthy food.

Another memorable moment occurred when Dr. Janine A. Rethy, a community medicine physician in Leesburg, Va., thanked the JLNV in front of a room of more than 60 people for our role in developing a healthy eating and active living program at HealthWorks for Northern Virginia.

Attending the Weight of the State conference was a great experience. All of the members who attended look forward to sharing their experience and ideas to help strengthen the League's community impact.

KIDS CAN LEADS SWIM CAMP

Swimming is an important life skill, yet not everyone knows how! Many of the children in the Arlington-Alexandria Coalition for the Homeless (AACH) shelter – now named Bridges to Independence – were lacking that skill, so seeking to fulfill a need, the Kids Can Committee set out to establish a program where these children could learn to swim in a safe, fun environment. A new partnership between the Junior League of Northern Virginia (JLNV), Arlington Parks and Recreation and the shelter was established, and a sixweek SWIM CAMP was born.

SWIM CAMP is a win-win-win because we were able to develop a new partnership, build upon our current shelter relationship, and expand our new focus area with both a new and existing partner.

Starting at the end of February and running through March, eight children — ranging in age from four to 15 — from the shelter partnered up with JLNV volunteers at a local Arlington pool to learn how to swim from a certified Parks and Recreation swimming instructor.





Each child made amazing progress over the six weeks — blowing bubbles, swimming freestyle, jumping into the deep end, and so forth. JLNV volunteers saw the confidence and abilities of these new swimmers grow each week and felt the children's clinging grips on them soften as the weeks went on.

The program was such a success that there's hope by all parties for another SWIM CAMP later this year. Thanks to all the volunteers for making the inaugural SWIM CAMP such a fun, rewarding success!

A CALL TO ACTION:

DEVELOPING THE POTENTIAL OF JLNV MEMBERS

JLNV Participates in the AJLI Organizational Development Institute

Each year the Junior League of Northern Virginia (JLNV) participates in the Association of Junior Leagues International's (AJLI) Organizational Development Institute (ODI). This unique training opportunity builds the knowledge of League members who manage the League's key functions and gives members the chance to learn more about best practices, from financial integrity to impacting the community to member engagement. As a part of our goal of developing the potential of women, this year the JLNV was pleased to send three delegates on partial scholarships to ODI training events:

- •Lisa Flach-Fulcher, treasurer, attended the Building Internal Capacity track in October in Kansas City, Missouri.
- •Kelly Cruz, secretary and incoming Fund Development Council Director, and Jhaymee "JW" Heinlein, incoming Treasurer-Elect, attended the ODI training in February in Grapevine, Texas.

All three ODI delegates came home with rave reviews about the ODI program. Lisa indicated she learned a tremendous amount about financial management for the League with an eye toward management of the Finance Council and maximizing the financial impact upon the community. She came home with many ideas for revising JLNV's financial policies and procedures, and tools to help her find information to assist her work with the League.

JW also attended a session on building internal capacity and was impressed with Vicki Clark's speech on "Moving Toward Diversity, Inclusion, and Cultural Competence," which covered AJLI's strategy on encouraging Leagues to focus on building more inclusive environments, regardless of race, gender, age and sexual orientation. She was thrilled to hear JLNV included as a case study on incorporating diversity and inclusion into

its long-term strategic planning. JW also came home with a renewed appreciation for risk management and hopes JLNV will consider developing a comprehensive risk management plan to cover all different types of aspects of events planning, operations and governance.

Kelly, who attended the fund development track, returned home with a newfound focus on the connection between the money and the mission (fundraising and community programming). She hopes a focus on this connection will empower League members and enable the Fund Development council to be more strategic in its planning.

All three delegates strongly recommend future and current League leaders attend ODI for not only the fantastic information, but also for the networking opportunities with other Leagues.

Kelly noted, "While it was an aggressive schedule, ODI was an opportunity for future leaders to share best practices. With one weekend dedicated strictly to learning about how the League's function, it is a great way to collaborate with other women who also want to better serve the League, its members and the community."

Similarly, JW said, "ODI is the perfect example of the Junior League mission in action. It is a wonderful opportunity for Junior Leaguers to strengthen their skills in fund development, strategic planning and operations. Plus, you'll have the opportunity to network with other Leagues, meet staff from AJLI, and share best practices".

Because of ODI's widespread popularity, this year JLNV has established a third date for the leadership training. Wendy Riemann will be attending the spring ODI May 29-31 in Charlotte, North Carolina. Scholarships to attend will be available again in the 2015-16 League year once next year's dates are announced.

MEMBERSHIP: RE-CAP OF THIS YEAR'S EVENTS

Having an engaged membership is essential for any organization to thrive. Without a strong membership base, the Junior League of Northern Virginia (JLNV) would be unable to do many of the great things we do each and every League year. Members are a major source of funding for the organization, and their manpower is essential for volunteer hours and the day-to-day maintenance of the organization.

With that in mind, the Membership Engagement Committee worked hard this year to grow the JLNV.

To start off, the recruitment team held a variety of events throughout the year to answer questions and share the Junior League experience. These events ranged from widely attended open houses at the JLNV headquarters to informal coffee chats and happy hours. A behind-the-scenes look at The Enchanted Forest served as a special recruitment event that allowed potential new members to get a sneak peek at the Forest and learn more about this annual fundraiser. Throughout the year, 46 potential new members came out to meet the women of the Junior League and learn more about our organization.

But recruitment is one part of the puzzle. Once women sign up, it's time to teach them about the JLNV and integrate them into the membership. That's where our Provisional Integration team came in. This team worked with more than 110 women across three provisional classes regarding their membership in the JLNV. Our Provisional Integration leads attended six provisional training sessions, hosted by the Leadership Development and Training Committee, answered hundreds of questions, and tracked thousands of requirement hours for these Provisionals as they made their way through the accelerated Provisional program toward graduation.

Through the hard work of both the recruitment and

Provisional Integration teams, the JLNV was able to bring to welcome new members into the League and guide them toward successful membership. These new members will be the future leaders of the JLNV, and we're excited to see all they contribute to our League.

BEING SAVVY WHEN GIVING BACK

What do you look for when choosing to donate to a charitable organization? Certainly mission, goods and services provided to the community, and credibility rank high on any donor's list, but do you ever check the organization's Form 990? What information can a Form 990 provide a savvy donor? The Finance Council has compiled the following information to assist you when choosing to give back to the community.

What is the Form 990?

Taken in conjunction with an annual report (report to the community) and/or other programmatic information, a Form 990 provides a brief, yet concise, snapshot of an organization's financial status.

Why Do Organizations File a Form 990?

Tax-exempt nonprofits do not pay federal taxes. They are required, however, to file a Form 990 — an informational form — with the IRS for every fiscal year of operation. The form is a public document, which allows the public and the IRS to evaluate nonprofits and how they operate.

Where Can Donors Access an Organization's Form 990? Form 990s, including the Junior League of Northern Virginia's, are available from a few sources, including the organization's main office itself. Nonprofit organizations are required to make their Form 990s available to the general public. Two organizations that do a good job of collection and publishing 990 forms are: GuideStar (www.guidestar.org), which offers a free search option after registering, and the Foundation Center (www.foundationcenter.org), by way of its 990 Finder feature.

What If an Organization Has Not Filed?

If you're having trouble finding any IRS forms for a particular organization, consider that a number of nonprofits are exempt from filing any type of return. Exempt organizations include:

 Organizations with gross receipts less than \$25,000 for the fiscal years before 2007;

- · Faith-based organizations;
- · Subsidiaries of other nonprofits;
- · Nonprofits that have not received tax-exempt status;
- · Religious schools; and
- Missions or missionary organizations.
